Our Grade I listed church dates back to 1140 and although it has been restored and partly rebuilt over the years, the roof is leaking and in urgent need of repair. The National Lottery “Grants for Places of Worship” Fund has awarded a grant of £195,500 towards the cost, but we still need to raise £65,000 to cover the costs of repairing the roof of the chancel, south transept and south side of the nave.
